## 18 December, 2021

Despite weather delays, a bad weather forecast, scheduled-date changes, and difficult schedules for business owners on the Parade route, the Mt. Juliet Christmas parade finally occurred and witnessed a great turnout of participants and spectators from the city's community.





The American Legion Post 281 of Mt. Juliet, in cooperation with the Post 281 Auxiliary, were the grand marshals at the front of the parade, along with "volunteered" members of the 230<sup>th</sup> Sustainment Brigade of the Tennessee Army National Guard in a variety of their latest tactical transportation vehicles titled a HMMWV, known as the Hummer, and a LMTV with Armor Plating on all sides. Six vehicles were at the front of the parade, with signs that announce the specific titles to conflicts and wars our country fought. Members of Post 281 had representatives from each of those periods inside each Tennessee Army National Guard vehicle.

Those periods covered the Korean War, with Post member and Army Veteran Rolus Smith riding in the lead vehicle. Then Army Veteran Dick Leady, and Navy Veteran Demar Smith from the Vietnam War followed. The Lebanon Grenada War member was Navy Veteran Wayne Smith, followed by Gulf/Persian War Air Force Veteran Carl Puels. The final vehicle represented those members who fought in the Global War on Terrorism, with Post members and Army Veterans Bobby Hibbett and Terry Ward representing that period.

Concept of Mt. Juliet's "Future" Miliary Wall of Honor



## <u>Service Officer News You Can Use</u> By Robert Hibbett, Service Officer

The Veterans Administration extends the presumptive period of chronic disabilities and illnesses for Persian Gulf War Veterans.

The definition of Gulf War Veterans:

For VA benefits eligibility purposes, the Gulf War period is still in effect. This means that anyone who served on active duty from August 2, 1990, to present is considered a Gulf War Veteran. For example, the Veterans Pension benefit requires service during a wartime period. Therefore, any Veteran who served on active military service for any period from August 2, 1990, to the present meets the wartime service requirement.

The Veterans Administration presumes that specific disabilities diagnosed in certain veterans were caused by military service. The VA has extended the Persian Gulf War Veterans period to December 31, 2026 so that they can file a compensation claim to the VA. The illnesses related to the Persian Gulf War service without regard to cause includes chronic fatigue syndrome, fibromyalgia, functional gastrointestinal disorders. Also included are undiagnosed illnesses with symptoms that may include but are not limited to abnormal weight loss, cardiovascular disease, muscle and joint pain, headache, menstrual disorders, neurological and psychological problems, skin conditions, respiratory disorders, and sleep disturbances.

Most of what was written came from the Veterans Administration.

## The Veterans Affairs Tennessee Valley Healthcare System (TVHS)

If a Veteran has not enrolled in Veterans Affairs health care yet, call 1-877-222-VETS or sign up on <a href="www.va.gov">www.va.gov</a>, or apply in person at the Nashville or Murfressboro VA campuses.

**SCAM Alert.** TVHS reports that scammers are using their main telephone number (615) 867-6000 and calling individuals, both veterans and non-veterans, about "qualifying for health insurance benefits." The scammers are asking individuals for their name, date of birth and additional information.

TVHS will never ask or call you to sign up for health insurance. If you receive a call from the above number, ignore it and never give out your personal information.

Anytime we call veterans, we will indentify ourselves.

# New Home Loans for National Guard and Reserve Members

National Guard and Reserve members without active duty service are now eligible to receive VA home loans.

The new law makes Guard and Reserve members who

have at least 90 days of service eligible for the home loan program, 30 days must have been consecutive.
